Subject: CLECs – (Product/Service) – **REVISED** - Update to the Non-Basic Inside Jacks and Wiring Ordering Process (Latest revision posted on August 25, 2004)

This is to advise that on July 25, 2004, ordering non-basic inside wiring and jacks became a mechanized process. This update is also associated with Change Control Process (CCP) No. 1978, TYPE 6.

When submitting a Local Service Request (LSR) electronically, the following REQTYPs are applicable:

- A Loops (Designed and Non-Designed)
- B Loops (Designed and Non Designed) with NP (where NPT = D)
- E Resale when 2<sup>nd</sup> position of TOS is H (ISDN BRI) & J (PBX)
- N PBX/DID when  $2^{nd}$  position of TOS is J (PBX) & Q (DID where AD = C)

Notwithstanding the foregoing, when requesting non-basic inside wiring and jacks for REQTYP A and B for an Unbundled Network Element (UNE) designed loop, CLECs must continue to submit LSRs manually in Georgia – Out State, South Florida and Southeast Florida. Please refer to the following area codes for further clarification:

South Florida = 305, 786, 727, 941 Southeast Florida = 561, 954, 631, 772, 754 Georgia – Out State = 706, 912, 478, 229

**Also**, for REQTYP A & B, the Associated Account Number (AAN) field of the LSR must contain the preassigned miscellaneous account number, which is assigned automatically as the LSR processes. The AAN field <u>must not</u> be changed to a different miscellaneous account number, i.e., BellSouth Premise Service (BPS) permanent miscellaneous account number. A change in the pre-assigned miscellaneous account number in the AAN field will result in an error on the LSR, and cause the LSR to be returned to the CLEC for clarification.

Additionally, when submitting a request for a Network Interface Device only, please submit the LSR manually. For such requests, BellSouth systems are currently rejecting LSRs with the following error message:

LSG00967 BAN1 DOES NOT MATCH BAN IN THIS SITE (RAO) FOR THIS REQTYP

For the exceptions cited above, BellSouth will bill the SOMEC charge in lieu of the SOMAN charge. Please add the following information in the REMARKS section of the LSR: "NID SOMEC"
