This is to advise that BellSouth has identified the following documentation defects in the LOH Version **17.0a** for TCIF 9 Release 17.0.

<b>CCP Number</b>	<b>Description Of The Change</b>
<b>2078</b>	Act of W REQTY E for DQTY: GLOBAL CHANGE: Change R/C/O table to show "DQTY" in the Required [row] on REQTY E Fast Packet (Frame Relay) for ACT = W. Refer to Conditional Usage Note 2 for DQTY in the Data Dictionary.
<b>2079</b>	Update to TOS Business Rule: The update to the TOS field in the Data Dictionary will be to add Non-Designed loops to Business Rule 11 for TCIF 9.
<b>2081</b>	Changes to R/C/O tables as the result of an audit of the Ordering LOH by the documentation team.

Please refer to the attachment for specific details of the changes listed above.

These changes will be reflected in the next update of the TCIF 9 Release 17.0/LOH Version **17.0b** scheduled to be posted on Monday, November 22, 2004.

**Business Rules**

Rule 1: TOS third character must not be F, if REQ TYP = F.

Rule 2: If TOS first character is '2', then the second character must be A, B, H, J, P, R or hyphen ( - ).

Rule 3: If TOS first character is '1', '2' or '3', then the second character must not be a "C".

Rule 4: If TOS first character is '4', then the second character must be "C".

Rule 5: TOS third character must be " - " (hyphen) if REQTYP = A, B, or C.

Rule 6: TOS second character must be "D" when REQTYP = N.

Rule 7: If REQTYP = P, the 2nd character of the TOS field must be "E".

Rule 8: When the 2nd character of the TOS field is "E", the 1st character can not be 2 or 4.

Rule 9: TOS third character must be "F" (Flat Rate) when ordering SynchroNet<sup>®</sup> service.

Rule 10: For REQTYP A, valid TOS entries are 1A-, 1B-, 1R-, 1P-, 2R-, 2P- and 19-.

Rule 11: For REQTYP A, Designed **and Non-Designed** Loops, the 2nd character of the TOS should indicate multi-line or single line based on the number of circuits being requested on the LSR, except for line sharing, line splitting, and EELs.

Rule 12: When both PBX and DID Trunks are on the same request, the second character of the TOS should be "J".

Rule 13: For REQTYP B and C, the TOS field must reflect the service that is currently on the BellSouth CSR.

Rule 14: If REQTYP = M (for UNE-P/WLP Centrex) the 2nd character of the TOS field must be "E" and the 3rd character must be "M".

Rule 15: When REQTYP=E (WATS) the 2nd character of TOS is D and the 4th character must be W.

Rule 16: When REQTYP=E (TFD) the 2nd character of TOS is D and the 4th character must be S.

Rule 17: The Fourth Character in the this field is only valid on Manually processed LSRs, prohibited with REQTYP B and C/NPT = D (LNA).

Rule 18: If the data in the LNECLS SVC field is a business class of service then the first character of the TOS must be 1.

Rule 19: If the data in the LNECLS SVC field is a residence class of service, then the first character of the TOS must be 2.

Rule 20: The valid fourth character TOS code of "F" should be used when the LSO field on the LSR is populated and the End User Address and ATN request is served out of a different C.O..

Rule 21: [BULK] For UNE to UNE BULK Ordering, TOS (Default) field is required once for every UNE to UNE BULK request. NOTE: If there is a mixture of account classes of service, TOS (Override) may be shown per EATN.

Rule 22: [BULK] TOS (Default) For UNE to UNE BULK Ordering. NOTE: If TOS entered at the BULK [Header] level, then all EATNs on BULK request will default to this TOS value.

Rule 23: [BULK] TOS (Override) is optional for UNE BULK Ordering. NOTE: Overridable at the Account level. If TOS entered at the Account level then this TOS will be applied to the EATN entered at this level when there is a mixture of account classes of service.

Rule 24: [BULK] Different TOS entries are allowable at the Account level based upon the valid UNE P services (identified in the CLEC Information Package) associated with a Bulk Package.
