LOH-22.0-ELMS06***Unauthorized Service Provider (Slamming)*****Description:**

Unauthorized Service Provider or "Slamming" is the illegal practice of changing a consumer's telephone service - local, intralata service, or interlata service (including state to state, in state and international long distance) - without permission.

When a CLEC is notified by their end user that they did not authorize a recent change to another Local Service Provider (LSP), the CLEC will issue an LSR to the LCSC notifying of a "Switch in Error". The LSR should be accompanied by the carrier's copy of the end user LOA.

Unauthorized changes for PIC (Predesignated Interexchange Carrier) and LPIC (Local Tolls Predesignated Interexchange Carrier) are handled by the *BellSouth Equal Access Service Center*. CLEC end users should report unauthorized PIC changes to the preferred CLEC. The preferred CLEC should contact the EASC for resolution.

The EASC will correct the PIC or LPIC and apply charges and/or credits associated with the PIC/LPIC change charge as appropriate.
