2463	LALOC field (DL Form/Screen): Change Data Characters from 35 alpha/numeric characters to 32 alpha/numeric characters.

These changes will be reflected in the next update of the ELMS 06 Release 24.0/LOH Version 24.0B, scheduled to be posted on Friday, January 26, 2007.

**LALOC**

Listed Address Locality  
DL Form / Screen  
24.0, LSOG6 / ELMS6

**Definition**

Identifies the locality or community to be listed.

**Definition Notes**

Note 1: A published address may contain only a community name. Use this field to indicate the community name to be listed.

**Valid Entries**

None

**Valid Entry Notes**

- Note 1: When the LALOC field is populated, it can not be populated with all capital letters unless the data is two or three upper case letters without spaces in-between them.
- Note 2: The only characters allowed in the LALOC field are alpha, numeric, space, apostrophe, and hyphen.
- Note 3: When the LALOC field is populated, it must be populated with a minimum of 2 characters and a maximum of up to 32 characters, beginning with an alpha character or a numeric character.
- Note 4: When the minimum of 2 characters is populated, they must both be upper case letters.
- Note 5: When a hyphen is populated in the LALOC field, an alpha or numeric or apostrophe is required before the hyphen and an alpha or numeric or apostrophe is required after the hyphen.
- Note 6: When an apostrophe is populated in the LALOC field, an alpha or numeric or hyphen or space is required before the apostrophe and an alpha or numeric or hyphen or space is required after the apostrophe.

**Data Characteristics**

Up to **35-32** alpha/numeric characters

**Conditional Usage Notes**

Note 1: Prohibited when the LACT field is Z.



- Note 2: Required when the RTY field is populated with FAC, FAL or FSP, and the primary state on the EU form is Georgia (GA).
- Note 3: Required when the RTY field is FAC, FAL or FSP, and the ADI field is not populated and the primary state on the EU form is not Georgia (GA).
- Note 4: Prohibited when the ADI field is populated.
- Note 5: Prohibited when the 2nd and 3rd character of the RTY field is CR.
