The Electronic Data Interchange (EDI), Local Exchange Navigation System (LENS) and the Telecommunications Access Gateway (TAG) systems will be unavailable for Local Service Request (LSR) processing on Saturday, March 10, 2007 from 6:00 PM EST until Sunday, March 11, 2007 at 11:00 AM EDT.

The Local Number Portability (LNP) Gateway, including Wireless LNP, will be unavailable for LSR processing on Saturday, March 10, 2007 from 6:00 PM EST until Sunday, March 11, 2007 at 11:00 AM EDT. No routine porting activity involving a Service Order Activation (SOA) notification or Local Service Management System (LSMS) broadcast, including Creates, Subscription Version (SV) and Pooled Blocks Activates, Modifies, Disconnects, Audits and Recovery will be performed during the system downtime.

The Fax Server for submitting manual LSRs will be unavailable on Saturday, March 10, 2007 from 6:00 PM EST until Sunday, March 11, 2007 at 11:00 PM EDT.

Telephone access to the BellSouth Local Carrier Service Center (LCSC) will be normal business operating hours.
