To: Competitive Local Exchange Carriers (CLEC), Independent Telephone Companies (ICO), Interexchange Carriers (IXC), Wireless Service Providers (WSP) and Payphone Service Providers (PSP)

Subject: CLECs, ICOs, IXCs, WSPs and PSPs – (Business/Operational Process) – Rate Center Consolidation of Seven Exchanges into the New Orleans Rate Center and the NPA Boundary Realignment for Area Codes 504/985 in the New Orleans LATA

On March 21, 2007, the Louisiana Public Service Commission (LPSC) in Special Order No.10-2007, approved a Rate Center Consolidation through which the Buras, Delacroix, Lake Catherine, Pointe-a-la-Hache, Port Sulphur, St. Bernard and Yscloskey exchanges will become part of the New Orleans exchange.

Also approved in this Special Order is the Area Code Boundary Realignment of the 985 NPA to the 504 NPA for the Buras, Port Sulphur, Pointe-a-la-Hache and Venice exchanges to become effective July 29, 2007. The Special Order grants a nine-month permissive dialing period, beginning July 29, 2007 at 12:01 AM (CT) and ending April 30, 2008 at 11:59 PM (CT), for the exchanges of Buras, Port Sulphur, Pointe-a-la-Hache and Venice, due to the resulting subscriber telephone number changes. During the permissive dialing period, calls to end customers located in Buras, Pointe-a-la-Hache, Port Sulphur and Venice may be completed using either the 985 or 504 NPA. Mandatory dialing of the 504 NPA begins May 1, 2008 at 12:00 AM (CT). All calls to end customers in Buras, Pointe-a-la-Hache, Port Sulphur and Venice must be dialed using the 504 NPA.

With the introduction of the Rate Center Consolidation of these seven exchanges into the New Orleans exchange and the 504/985 NPA Boundary Realignment (Notice of Network Change Number 20070045), Automatic Number Identification (ANI) conversions are scheduled for AT&T switches located in the areas receiving the new area code. Please refer to the attached schedule for a list of the AT&T switches located in the New Orleans exchange.

All work associated with the ANI conversions is scheduled in the following three (3) phases:

August 7, 2007 at approximately 6:00 PM (CT) until August 8, 2007 12:00 PM (CT)

August 9, 2007 at approximately 6:00 PM (CT) until August 10, 2007 12:00 PM (CT)

August 14, 2007 at approximately 6:00 PM (CT) until August 15, 2007 12:00 PM (CT)

Also refer to the attached schedule to determine the specific AT&T switch involved in each of the above phases.

Some Integrated Services Digital Network (ISDN) customers will be required to change their Service Profile Identified (SPID) numbers in their ISDN equipment in association with the upcoming ANI conversions. An instructional letter will be mailed to the affected customers before the ANI conversion date.

Rate Center Consolidation of the Delacroix, Lake Catherine, St. Bernard and Yscloskey exchanges into the New Orleans exchange does not involve a subscriber telephone number change. However, Rate Center Consolidation of the Buras, Pointe-a-la-Hache and Port Sulphur exchanges will involve a subscriber telephone number change from the 985 NPA to the 504 NPA. In addition, the NPA Boundary Realignment also involves moving the Venice exchange from the 985 NPA to the 504 NPA to avoid isolating a small pocket of the 985 NPA. Basic local calling areas of the exchanges will be expanded to that of New Orleans.
