December 2005 performance results for SBC Midwest performance measurements are now available.

### ***2005 Six-Month Review Performance Measures Change Implementation:***

Implementation of the 2005 Six-Month Review performance measurement changes has begun with December 2005 performance results. These changes will be implemented through March 2006 results published April 20, 2006. The Rules V2.0d have been updated via redline and posted on the web site to reflect the changes agreed to in the Six-Month Review that have been implemented with December 2005 reporting.

### ***Effective with December 2005 data:***

- PMs 5.2, 10.4, 20, 27, 28, 32, 35.1, 74, 77, 93, 103, 104.1, 106, 108, 118, 121, 125, MI 4, MI 5, MI 9, MI 10, MI 12, MI 13.1, MI 16, CB 2, and CLEC WI 4 have been discontinued and results for future months, beginning December 2005, will not be reported.
- PM 5 Tails disaggregations have been discontinued and results for future months, beginning December 2005, will not be reported.
- PMs 1.1, 1.3, 2, 5, 22, 22.1, 35, 37.1, 38, 39, 40, 41, 46, 47, 49, 50, 52, 53, 54.1, 55, 56.1, 59, 62, 65.1, 66, 67, 68, 69, 73, 75, 101, 109, 115, 126, CB 3, CLEC WI 1, MI 2, and WI 2 have been updated to reflect all documentation-only changes.
- PM 37.1 has been changed to combine Business and Residence submeasures under a single submeasure.
- The Dispersion Report for Average Response Time for OSS Pre-Order has been eliminated.
- PM 70 has been changed to a Benchmark measure for all States. Reporting of Retail is discontinued and 2 new exclusions are applied to the data.
- Geographic disaggregation of PMs 35, 37.1, 54.1, and 65.1 has been eliminated. Results are now reported at the State level only.
- Remedies now apply to PM 29.
- PM 2 has been updated as follows: a) the benchmark for the disaggregation "Actual Loop Makeup Information requested (greater than 5 loops searched)" is changed from "Diagnostic" to "95% in <= 60 seconds"; b) the benchmark for the disaggregation "Protocol Translation Time – EDI where the message

size is greater than 65K" is changed from "Diagnostic" to "95% in  $\leq 4$  seconds"; and c) the benchmark for the disaggregation "Address Validation" is changed from 10 to 20 seconds.

- The four Attachments to the Business Rules have been reduced to two with the elimination of "Advanced and Nascent Services" and the "Performance Measures with Remedy Limits".
