

## Web Site News As Of January 21, 2003

Welcome to the Ameritech Performance Measurements web site.

December 2002 performance results for all SBC Ameritech performance measurements are now available.

### ***Business Rule Update:***

The SBC Ameritech Performance Measurement Version 1.8 Business Rules are accessible via the Current Business Rules link at the bottom of this page. Any modifications made to the current business rules are listed in the Business Rules Modification Matrix. Previous month Business Rules, along with previous month Business Rule Modifications Matrices can be found in the Historical Business Rules section.

### ***Performance Measures Targeted for Recalculation and Reposting:***

Listed below are the measures for which previously reported results are targeted for reposting on February 5, 2003.

- A coding error caused an error in the way that the jeopardy results are calculated and in the way the changed due dates are identified for Unsolicited FOCs. This affected results for PM 10.4 and MI 2. The error has been identified and corrected. June 2002 results will be recalculated and reposted.
- Misinterpretation of application logic caused the results for PM 106 to be calculated using business days versus calendar days. The appropriate logic will be applied and the July 2002 thru November 2002 results will be recalculated and reposted.

### ***Please note:***

- The EDI LSOG 1 Interface was retired in November 2002. Accordingly, no data will be reported for this interface type under PM 4.
- The Oracle database hosting SBC Midwest applications is going to be upgraded on Saturday, January 25, 2003 from 6:00 P.M. until Midnight. The applications will be unavailable for approximately 6 hours. This news page plus access to PM results will be unavailable during that time.
- Manual FOCs delivered via fax will use a running clock routine for tracking and reporting FOC durations. This affects results for PM 5 and PM 6 and will be effective with December results posted on January 21.
- The SBC Midwest benchmark percent and counts will no longer be reported for PM 13.1 effective with December results posted on January 21. As defined in the version 1.8 business rules, this measure is diagnostic and does not have a standard of comparison.
