Recalculated and Reposted Performance Measures:

Listed below are the measures for which previously reported results have been recalculated and reposted. AT&T Midwest makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- March through May 2005 results for performance measures 55.2 and 56.1 have been recalculated and reposted to incorporate coding and date/time format changes.
- April through June 2005 results for performance measures 55.2, 56.1, and 96 have been recalculated and reposted to correct for a logic problem that resulted in certain orders not being reported.
- June through September 2005 results for performance measures 35, 37.1, 38, 39, 40, and 41 have been recalculated and reposted to correct for a logic problem that resulted in trouble reports for internal AT&T circuits or lines that are not retail lines or circuits being erroneously included in Retail results.
- July through October 2005 results for performance measure 115 have been recalculated and reposted to correct coding problems and the use of an obsolete data file in processing that resulted in certain orders not being reported.
- June through December 2005 results for performance measures 35, 37.1, 38, 39, 40, and 41 have been recalculated and reposted to correct for a logic problem that resulted in a number of Local Wholesale Complete orders being incorrectly included in aggregate reported UNE-P results.

- October 2005 results for performance measures 35 and 37.1 in Illinois have been recalculated and reposted to correct a system processing problem that resulted in orders for a single day being excluded from reporting.
- November 2005 results for performance measures 110 and 113 in Michigan have been recalculated and reposted to include records for a single CLEC that were omitted from results due to a data processing error.
