February 2003 performance results for SBC Midwest performance measurements are now available.

2002 Six-Month Review Performance Measurement Change Implementation:

Implementation of the 2002 Six-Month Review performance measurement changes has begun with February 2003 performance results. The 2002 Six-Month Review Agreed-To Measurement Change Implementation Schedule indicates the performance measurements that were implemented on March 20, 2003; as well as targeted implementation dates for other performance measurements. As the schedule indicates, PMs 2, 5 and 6 have been implemented ahead of the implementation date required. PM 91 was implemented ahead of the implementation date required, with changes to customer desired due date applied to service orders generated from mechanized LSOG5 LSRs only. Results to be posted on April 21, 2003 will apply this additional change to service orders generated from LSOG4 LSRs.

The SBC/Ameritech Performance Measurements User Guide Version 1.9 has been posted, exactly as filed, and details 2002 Six-Month Review agreed-to (color-lined) changes. The SBC/Ameritech Performance Measurement User Guide Version 1.8 will continue to be posted until all 2002 Six-Month Review changes have been implemented. Recalculated and Reposted Performance Measures:

Listed below are the measures for which previously reported results have been recalculated and reposted on April 7, 2003. SBC Ameritech makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally-posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- For LNP with loop orders, the related order field was not always populated, resulting in certain LNP with loop orders being reported as loop orders. An enhanced process to more accurately identify the related orders has been implemented. February 2003 results for PMs 55, 55.2, 56, 56.1, 96 and 97 have been recalculated and reposted.
- The criteria logic for CLEC WI 5 did not include all of the wholesale requests for Resold Design Specials and UNEs. The criteria logic has been modified and February 2003 results have been recalculated and reposted.
- An incorrect data field was used to calculate the February 2003 results for PM 59, affecting the results for the Line Share disaggregation. In addition, an internal performance measurement processing system problem affected the February 2003 results for the non-Line Share disaggregations for PM 59 and the disaggregations for Resold Specials for PM 46. The correct data field has been identified for PM59 and the PM processing system problem has been addressed and corrected for PMs 46 and 59. February 2003 results for PMs 46 and 59 have been recalculated and reposted.

Please note:

- Results for IN 1 for Ohio were improperly displayed for January 2003 due to an internal manual data entry problem. The data entry process problem has been addressed, and January 2003 Ohio IN 1 results are now displayed properly.
- Effective on March 7, 2003, the Restatement Report has been enhanced to include a new column DISPLAY_ONLY(Yes/No). This new information will differentiate changes in performance report results that are due to recalculation of actual performance (No) from changes in the report display only (Yes).

- On March 12, 2003, the Federal judge granted an injunction against the IURC remedy plan. All special Indiana reports required by the IURC Remedy Plan has been removed from the web site.
- The *undetermined, unknown and null (for non-telemangement segments only)* order class codes for LSOG4 only, used for reject orders that could not be fully identified due to CLEC error, have been included in the results for PMs 5.2, 9, 10, 10.1, 10.2, 10.3, 11, 11.1, 11.2. Since the Loop Recovery Form order class code is not a wholesale activity, it has been removed from these reject measures.
- PM 7.1 code logic has been updated to ensure that specific types of orders identified as CLEC-Caused Misses are properly excluded in result calculation.
- The calculation to determine a premature coordinated conversion for PM 114 has been modified to be based upon the disconnect occurring any time SBC Midwest disconnects the CLEC customer 10 or more minutes prior to the CLEC being on line.
