

Web Site News As Of May 5, 2004

Welcome to the SBC Midwest Performance Measurements web site.

March 2004 performance results for SBC Midwest performance measurements are now available.

Business Rules:

The SBC Midwest Performance Measurements User Guide Version 2.0 has been posted, exactly as filed, and details 2003 Six-Month Review agreed-to (color-lined) changes. Also posted is a clean copy of Version 2.0 with all track (agreed-to) changes accepted. The SBC/Ameritech Performance Measurement User Guide Version 1.9 will continue to be posted until all 2003 Six-Month Review changes have been implemented. The User Guides are accessible via the User Guide link.

SBC Midwest has identified a number of conflicts within the SBC Midwest Performance Measurement User Guide Version 2.0. The matrix outlining these known/identified business rule conflicts will be updated as needed and is accessible via the User Guide link. These conflicts will be addressed through SBC proposals in the upcoming Six-Month Review PM Collaborative

Recalculated and Reposted Performance Measures:

Listed below are the measures for which previously reported results have been recalculated and reposted. SBC Ameritech makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- February 2004 data for PM 97 has been recalculated and reposted to accurately reflect when the 10 digit trigger was applied to orders that were part of a project in Indiana.
- March 2004 data for PM 65.1 has been recalculated and reposted to reflect the proper metro area on the Interconnection Trunk data. The data had previously been reported with an "undetermined" metro area.
- February and March 2004 data for PMs WI 1 and WI 2 has been recalculated and reposted to correct a posting problem which prevented display of the retail result and the z-score result.

Please note:

- The display for March 2004 results for PM 13 for the UNE-P disaggregation has been redisplayed to show the benchmark of 95% as required by the 2.0 Business Rules, rather than a parity comparison.
- The display for March 2004 results for PM 104 has been redisplayed to show "the Percent of 911 Updates Processed within the Established Timeline" and a

benchmark of 95%. Previously, the percent of 911 updates NOT processed within the established timeline was displaying, along with a benchmark of 5%.

- SBC Midwest has been reporting a Broadband service under the UNE Installation and Maintenance Broadband DSL sub-measures that was not provisioned as a UNE under Section 251 of the Act. Reporting of this service within the Broadband DSL sub-measures will be discontinued effective with May 5, 2004 reporting, for PM 60, as the PMs are required to report only on SBC Midwest's performance with respect to UNEs under Section 251(c) of the Act. Going forward, Broadband DSL UNE PM results will include only those circuits purchased, provisioned and maintained as Broadband DSL UNE circuits, if any. (This change has been implemented for all PMs except PM 60 with the April 20, 2004 posting.)
- The display change limitations noted on the February 20, 2004 News Page continue for this month's posting. With this change the affiliate results will only appear in the column labeled "Affiliate". In the past the affiliate results were replicated in the Retail column when there were no Retail results and the affiliate data was used for generation of the z-value. The exceptions to this change with the current display are DSL and Broadband DSL line sharing disaggregations of PMs 55, 55.3, 56, 58-63, 65-67 and 69 as well as PMs 1.1, 1.3, MI 4, MI 10 and MI 16. For those measures the affiliate results are also reported in the Retail column. SBC Midwest is working to address this display issue and will provide notification via this web page when this enhancement is completed. The issue has no impact on determination of pass or fail, or on payment of remedies, for the individual measures.
