

## Web Site News As Of May 5, 2005

Welcome to the SBC Midwest Performance Measurements web site.

March 2005 performance results for SBC Midwest performance measurements are now available.

### ***Recalculated and Reposted Performance Measures:***

Listed below are the measures for which previously reported results have been recalculated and reposted. SBC/Midwest makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- December 2004 through February 2005 results for performance measures 2, 7.1, 9, 10, 10.4, MI 2, MI 10, and MI 16 have been recalculated and reposted to correct for data processing logic changes that inadvertently resulted in the incorrect exclusion of certain records for a very limited number of CLECs.
- December 2004 and February 2005 results for performance measures 118 have been recalculated and reposted to correct a file format problem that caused results to be erroneously reported on the web site.
- January 2005 results for performance measure 40 have been recalculated and reposted to correct program coding problems that caused UNE-P maintenance trouble reports to be understated in Ohio.
- February 2005 results for performance measure 65.1 have been recalculated and reposted to correct for a processing problem that caused Interconnection Trunk disaggregation denominator results not to display.
- February 2005 results for performance measure CB 4 have been recalculated and reposted to include data from a single file that was inadvertently omitted from the normal production run, resulting in understated volumes.
- March 2005 results for performance measure 10 have been recalculated and reposted to correct for a processing problem that caused all manual/manual rejects for Illinois, Indiana, Michigan, and Ohio to be reported in Wisconsin, overstating Wisconsin volumes and understating volumes in the other states.
- September through November 2004 results for performance measures 43 and 45 have been recalculated and reposted to correct for a change in performance measure criteria that inadvertently caused some Resold ISDN BRI wholesale records to be reported under the UNE Loop & Port ISDN BRI disaggregation.

***Please Note:***

- The Business Rules V2.0 have been updated (see V2.0b) to reflect the implementation of the 2/23/2005 PUCO Order on the disputes. The changes for PMs 100 and 113 were implemented with February 2005 results and the change to CLEC BLG-3 was implemented with March 2005 results. All remaining changes will occur with April, May or June 2005 results including the implementation of this Order in Illinois, Indiana, Michigan and Wisconsin reporting as agreed to by the PM Collaborative.
- The CLEC Website Performance Measures page now has the option to pull Remedy Reports by Performance Month or Run Month. This allows the user to further define his search to retrieve the precise information needed.
