Welcome to the SBC Midwest Performance Measurements web site.

May 2005 performance results for SBC Midwest performance measurements are now available.

Recalculated and Reposted Performance Measures:

Listed below are the measures for which previously reported results have been recalculated and reposted. SBC/Midwest makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- April 2005 results for performance measures 17, 27, 28, 29, 35, 37.1, 38, 39, 40, and 41 in Ohio have been recalculated and reposted to correct for an issue where transactions that were not UNE-P were included in the reported results as UNE-P activity.
- December 2004 through March 2005 results for performance measure 59 have been reposted to correct for a processing error where the Z-Values were not calculated and displayed for the EELs-Digital and EELs-Transport disaggregations.
- April 2005 results for performance measure 67 in Michigan have been recalculated and reposted to correct for a processing error that caused reporting of March 2005 data a second time in April 2005, rather than report April 2005 data for those results.

Please Note:

- The Business Rules V2.0 have been updated (see V2.0b) to reflect the implementation of the 2/23/2005 PUCO Order on the disputes. The changes for PMs 100 and 113 were implemented with February 2005 results and the change to CLEC BLG-3 was implemented with March 2005 results. All remaining changes will occur with April, May or June 2005 results including the implementation of this Order in Illinois, Indiana, Michigan and Wisconsin reporting as agreed to by the PM Collaborative.
