

## **Web Site News As Of August 5, 2003**

Welcome to the SBC Midwest Performance Measurements web site.

June 2003 performance results for SBC Midwest performance measurements are now available.

### ***Business Rules:***

The SBC/Ameritech Performance Measurements User Guide Version 1.8, the color-lined Version 1.9 and the 2002 Six-Month Review Agreed-To Measurement Change Implementation Schedule have been moved to the Historical Business Rules section. The "clean" SBC/Ameritech Performance Measurements User Guide Version 1.9 is accessible via the link shown below. All versions of the User Guide are accessible via the User Guide links at the bottom of the page.

SBC/Ameritech has identified a number of conflicts within the SBC/Ameritech Performance Measurement User Guide Version 1.9. The matrix outlining these know/identified business rules conflicts will be updated as needed and is located at [Conflict Matrix](#). SBC Midwest expects to address these conflicts in the next six-month review collaborative.

### ***Recalculated and Reposted Performance Measures:***

Listed below are the measures for which previously reported results have been recalculated and reposted. SBC Ameritech makes available a listing of the recalculated and reposted performance measurement results that have also been restated (changed from the originally posted result) in the Reports section of this website. These reports are available for both CLEC-aggregate results and CLEC-specific results, and are accessed in the same manner as existing performance measurement reports.

- Ohio May 2003 results for PM 97 were recalculated and reposted on July 20, 2003 to include additional source data not included in the originally posted results. Lack of this data in the original results caused LNP telephone numbers that were associated with a project to be improperly identified as misses.
- July through September 2002 results for PM 117 and 118 have been recalculated and reposted on August 5<sup>th</sup> to address situations where an account completed in the same week as the LERG Effective Date could have been identified as completing on-time when they may not have met the LERG Effective Date.
- In response to Bearing Point Observations 623, 645, 646, 796 and 797, July through September 2002 results for PMs 105, 106 and MI 5 have been recalculated and reposted on August 5<sup>th</sup>.

### ***Please note:***

- The LSOG 6 release (replacing LSOG 4 and MORTEL) took place on June 13, 2003 through June 14, 2003 affecting the availability of the Electronic Ordering and Pre-Ordering Systems. The specific system downtimes were outlined in Accessible Letter CLECALLS03-077.
- Effective with June 2003 performance results, Illinois data shown under the "State Performance Measurements" option is reported using the Section 271 Remedy Plan approved by the Illinois Commerce Commission in Docket 01-0662. This remedy plan is available in the "Remedy Plan Information" section below and can be accessed via the "Illinois Remedy Plan Description (IL271)" link.
- An internal system processing problem caused the June 2003 MI 5 results not to be displayed. The system problem has been corrected and June 2003 results are available.
