July 2003 performance results for SBC Midwest performance measurements are now available.

Business Rules:

The SBC/Ameritech Performance Measurements User Guide Version 1.8, the color-lined Version 1.9 and the 2002 Six-Month Review Agreed-To Measurement Change Implementation Schedule have been moved to the Historical Business Rules section. The "clean" SBC/Ameritech Performance Measurements User Guide Version 1.9 is accessible via the link shown below. All versions of the User Guide are accessible via the User Guide links at the bottom of the page.

SBC/Ameritech has identified a number of conflicts within the SBC/Ameritech Performance Measurement User Guide Version 1.9. The matrix outlining these known/identified business rules conflicts will be updated as needed and is located at <u>Conflict Matrix</u>. SBC Midwest expects to address these conflicts in the next six-month review collaborative.

Please note:

- On August 26, 2003, the MPSC ordered SBC to eliminate the K table. This order is retroactive to April 2003 performance measurement results and, as ordered, has been effected on September 5, 2003. This affects Tier 1 remedies for Michigan only. The applicable Michigan Remedy Plan information, accessed via links shown below, has been updated. The Plan has also been updated to reflect the changes to the Appendices which were agreed to in the collaborative, filed on January 17, 2003 (U-11830) and approved in the MPSC Order of February 20, 2003. Appendices 2 & 3 were removed and now reflected as Attachments Two & Three to Appendix 1.
- Per the SBC/Ameritech Performance Measurements User Guide Version 1.9, PM 35.1 is a diagnostic measure. As such, retail results, previously posted, are not required and the display for this PM has been modified effective with July 2003 results.
- Effective with July 2003 performance results, for PM 2: % Response Received w/in 60 Sec--OSS Interface--Customer Service Inquiries > 30 WTNs/lines diagnostic disaggregation, the benchmark display has been modified to show a 95% benchmark as is required by the SBC/Ameritech Performance Measurements User Guide Version 1.9.
- Per the Indiana Administrative Code, Telephone Utilities, Answering Times (170 IAC 7-1.2-16), http://www.in.gov/legislative/iac/title170.html, the benchmark for PM 80 (previously 7.7 sec) and PM 82 (previously 3.3 sec), has changed to 20 seconds for both PMs. The change in benchmark is reflected in the posted March 2003 thru July 2003 Indiana results.
- The benchmark display for PMs 65 and 65.1 has been changed from a decimal to a percent, as required by the business rules.
- Effective with July 2003 results, Affiliate results will no longer be posted for PMs 4, 14, 20, 21.1, 22, 22.1, 24.1, 25, 79, 80, 81, 82, 83, 124.1, MI 11 and MI 15.

- Affiliate results are not required to be posted per the PM business rules Report Structure for these PMs.
