#### SBC Midwest CLEC Web Site Update - March 7, 2003

The Restatement Report for the March 5th, 2003 posting of recalculated results has been enhanced to include a new column, DISPLAY\_ONLY (Yes/No). This new information will differentiate changes in performance report results that are due to recalculations of actual performance data (No), from changes in the reports for display purposes only (Yes). The enhanced report provides the functionality of the special report entitled '03-05-03RestatementsNotDueToINPostingChanges', that was identified in the March 6, 2003 Web Site Update.

#### SBC Midwest CLEC Web Site Update - March 6, 2003

The restatement report for the March 5th, 2003 posting of recalculated results has now been posted. The majority of the restated results listed in the detailed report are in fact display-only changes. These notifications do not indicate that previously reported performance results were changed. The display-only changes, described below, result from SBC Midwest's implementation of requirements of the IURC's Remedy Plan that were implemented in reporting for all five SBC Midwest states. The display-only changes are described below.

- Results for PM's 14, 20, 21.1, 22, 24.1, 25, 79, 80, 81 and 82 for June 2002 through January 2003 for Illinois, Indiana, Michigan, Ohio, and Wisconsin are now displaying the company-level result in the affiliate value on the aggregate report. The actual company level results did not change. In addition, this change removed the display of results for these PMs from the individual CLEC results previously displayed, as these results are not reported at a CLEC-specific level.

- As required by the IURC Remedy Plan, Z-values are now displayed for bright-line benchmark measures. Display of the Z-value for these PMs has been added with June 2002 results forward for all SBC Midwest states. The earliest this data could have been required to be displayed under the IURC Remedy Plan was with November 2002 results.

- As required by the IURC Remedy Plan, measures for which there is no wholesale activity to report, but for which there are SBC retail and/or affiliate results, will have the SBC Retail and/or affiliate results displayed. This has been implemented for June 2002 result forward for all SBC Midwest states. The earliest this data could have been required to be displayed under the IURC Remedy Plan was with November 2002 results.

The SBC posting of the document titled, '3-5-03RestatementsNotDueToINPostingChanges', as of March 7, 2003 identifies the measures that have been restated for reasons other than the effects caused by the implementation of these new posting practices.

The March 4, 2003 posting corrected certain situations where a zero was appearing in the CLEC denominator when there was no data to report for January 2003 Illinois, Michigan, Ohio, and Wisconsin results. This situation has been corrected for June 2002 through January 2003 for Indiana results.
